## TRAVEL TRAILER-RENTAL TERMS AND POLICIES

RENTERS-Must be at least 25yrs of age and have a valid Texas driver's license. Renter must complete all required forms. Renter also must provide proof of personal liability insurance for **Your Own** tow vehicle. You must contact your insurance company and advise that you will be pulling a rented camper so that they can endorse/verify your policy for compulsory liability insurance.

RESERVATION DEPOSIT IS-\$200.00 and will be applied to the rental fee. Reservation deposit is payable by accepted credit card, check, or cash. Cancellation of your reservation will AUTOMATICLY add a \$25.00 cancellation fee to your credit card, however, there will be NO refund for cancellation 30 days prior to departure. A copy of your liability insurance card, major credit card, and Texas driver's license is due at time of reservation. Units must be reserved at least 48 hours in advance, not including holidays and weekends. The total amount due for rental must be paid before departure. Plus have **YOUR** credit card for the damage deposit of \$600.00(\$1,000 w/awning use).

SECURITY/DAMAGE DEPOSIT IS a minimum of \$600.00(\$1,000 for awning use), AND IS REFUNDABLE-required prior to departure and covers any additional cleaning, washing, missing items, damages, and any other charges that may be incurred. Deposit is payable by **YOUR** accepted credit card. Your deposit will be available for return no sooner than 48 hours after return.

DAMAGES/BREAKDOWNS/REPAIRS-You **must** notify J & S of any damages, failures, or repairs needed. If it is necessary to have repairs made during your trip, receipts and old parts must be returned to us for reimbursement. If repairs involve more than \$50.00, you **MUST** have prior approval for repairs, before reimbursement will be made. CALL 281-383-3242 FOR ASSISTANCE OR APPROVAL.

HITCH REQUIREMENTS-CLASS 3 RECEIVER HITCH, RV TYPE 7-WAY PLUG IN, 2 5/16 BALL, ELECTRIC BRAKE CONTROLLER **(YOU MUST CONTACT US PRIOR TO YOUR RENTAL PICK UP IF YOU DON'T HAVE ALL OF THIS)**

FAMILIARIZATION TOURS-approximately 30 minutes is required to acquaint the renter with the operation of the camper before departure. This tour is scheduled at time of pick-up.

CAMPERS-are not permitted in Mexico or Canada. Campers are not permitted on "logging roads" or any other non-public roads. Renter is responsible for any damage to camper regardless of circumstance. **No roof storage allowed!!!!**

NO SMOKING/NO PETS/NO FISH/SEAFOOD ALLOWED IN CAMPER. You will lose your DAMAGE DEPOSIT of \$600.00 **plus** additional cost of clean up, if there is ANY evidence of this in our campers.

AWNING-awning cannot be used without an "Awning Use Agreement" on file. Awning use is at full liability for all damages to the Lessee.

PICK-UPS/RETURNS- Your rental starts at the time the unit is picked up. A rental day is each calendar day that you have the unit in your possession. All departures by appointment. We will accept returned units Monday-Sunday from 9:00a.m. - 5:00p.m.as scheduled by appointment. ALL UNITS WILL BE CHARGED A **\$50.00 PER HOUR LATE FEE(min. 1hr charge)** IF RETURNED LATE. **YOU MAY NOT RETURN UNIT PAST RETURN TIME.** (UNLESS PRIOR PERMISSION GIVEN). YOU WILL OWE AN ADDITIONAL DAY AND WILL NEED TO COME THE NEXT DAY. PLEASE CALL OUR 24- HOUR NUMBER TO LET US KNOW IF YOU WILL BE LATE AND RETURNING THE NEXT DAY. WE WILL NOT REFUND RENTAL IN WHOLE OR PART FOR EARLY RETURNS OR FOR ANY OTHER REASON.

RETURNING CAMPER-cleaning fees will be charged if the camper is not returned clean( **CLEAN MEANS CLEAN ENOUGH TO SEND BACK OUT ON RENT**) on the **INTERIOR and EXTERIOR**. IF YOU PULL WITH A DIESEL VEHICLE, YOU MUST CLEAN OUTSIDE OF SOOT. All clean up will be charged at \$75.00 per hour with one-hour minimum. There is a \$45.00 fee for emptying holding tanks. This includes rinsing of the tank with water and leaving the dump valves open when you return the unit so there will be no question of the unit being dumped sufficiently. **We will automatically assume the unit has not been dumped and charge you the \$45.00 if the caps are not open.** Also, a \$40.00 per cylinder charge for propane if it is not returned filled. **You must have a receipt for proof of filling.** Keys or electrical converter not returned will be charged at \$10.00 plus cost. Check unit for cleanliness or damage and note on agreement before departing. We are not responsible for any items left in camper after returned.

VIOLATIONS-lessee is responsible for paying all parking or driving violations plus handling fee. Lessee is responsible for reporting all accidents IMMEDIATELY to the proper authority and to J & S Services.

LESSOR'S ability to provide a rental unit, if reserved, is contingent upon and subject to the return of the unit by the previous Lessee, and to accidents and other causes beyond Lessor's control.
